

**HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 345**  
**NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being a meeting place of the District.

**The meeting will be held on Monday, November 20, 2023, at 12:00 Noon.**

The Board shall consider and/or act on following matters:

1. Public comments;
2. Review and approve minutes of the October 16, 2023, Board of Directors meeting;
3. Acceptance of resignation letter from Director Kingma and discuss appointment of a new Director to fill the vacancy on the Board of Directors;
4. Reorganization of the Board of Directors;
5. Bookkeeper's Report, including financial and investment reports and authorizing the payment of invoices presented;
6. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
7. Review and consider approval of Energy Management Agreement between the District and Acclaim Energy Advisors;
8. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
9. Delinquent tax collections attorney report, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Engineer's Report, including:
  - (a) Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of Texas Ethics Commission ("TEC") Form 1295;
  - (b) Status of construction contracts, including the approval/and or concurrence of any pay estimates and change orders and/or acceptance of facilities for operation and maintenance purposes, authorization to accept

- of TEC Form 1295, approval of any related storm water permits and approving of related storm water plans, including:
    - i. Installation of generators at the District's Lift Station Nos. 1 and 2 (CSE W-Industries, Inc.); and
    - ii. Installation of a generator at the District's Joint Wastewater Treatment Plant (CSE W-Industries, Inc.);
  - (c) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
  - (d) Approval of any consents to encroachment relative to District facilities;
  - (e) Discussion regarding the status of repairs to sidewalks and trails located within the District by Harris County Precinct 4 and Harris County Municipal Utility District No. 346;
  - (f) Status of service line inventory required under new lead and copper regulations (due October 2024); and
  - (g) Capital Improvement Plan;
- 11. Status of acquisition of property owned by Second Baptist Church for a second water well; authorize any action in connection therewith;
- 12. Operator's Report, including:
  - (a) Monthly Report;
  - (b) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
  - (c) Appeals of District charges;
  - (d) Refer accounts for collection;
  - (e) Write-off of uncollectible accounts;
  - (f) Repair and maintenance of District facilities;
  - (g) Status of water meter replacement program;
  - (h) Implementation of Drought Contingency Plan;
  - (i) Status of testing District's water supply for arsenic levels; and
  - (j) Receive presentation from Harris County Public Health Department regarding participation in Wastewater-Based Epidemiology Program;
- 13. Status of testing District's water supply for arsenic levels;
- 14. Green Trails Monthly Report regarding supplemental law enforcement services;
- 15. Communication with District residents, including mass communication messaging system by Classic Messaging LLC; review proposals for District website; authorize any action necessary in connection therewith;
- 16. Status of installation of a hike and bike underpass on Fry Road by Willow Fork Drainage District;

17. Attorney's Report, including acknowledgement of receipt of Municipal Securities Rulemaking Board Rule G-10 disclosures;
18. Authorize filing of Eminent Domain Report with the Texas Comptroller of Public Accounts prior to February 1, 2024, pursuant to Section 2206.154, Texas Government Code;
19. Discuss status of potential litigation involving the District and authorize any action in connection therewith;
20. Convene Closed Session for consultation with attorney regarding pending or threatened litigation or matters protected by attorney-client privilege pursuant to Section 551.071, Texas Government Code, as amended, and deliberation regarding the purchase, exchange, lease, or value of real property pursuant to Section 551.072, Texas Government Code, as amended;
21. Reconvene in Open Session and authorize any actions related to matters discussed in Closed Session; and
22. Matters for possible placement on future agendas.
