NOTICE OF SPECIAL PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a special public meeting at 1300 Post Oak Boulevard, Suite 2400, Houston, Harris County, Texas, said address being a meeting place of the District.

The meeting will be held on Monday, July 1, 2024, at 12:00 Noon.

The Board shall consider and/or act on following matters:

1. Public comments;
2. Review and approve minutes of the May 20, 2024, Board of Directors meeting;
3. Bookkeeper's Report, including financial and investment reports and authorizing the payment of invoices presented;
4. Consider amendment to general operating budget, Joint Wastewater Treatment Plant budget, and Joint Water Plant budget for fiscal year ending January 31, 2025;
5. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
6. Delinquent tax collections attorney report, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
7. Consider approval of Assignment and Amendment of Agreement Between Owner and Engineer for Professional Services by and among the District, Costello, LLC, and Pape-Dawson Consulting Engineers, LLC;
8. Engineer's Report, including:
 - (a) Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of Texas Ethics Commission ("TEC") Form 1295;
 - i. Water Plant Improvements Project, Phase 1;
 - ii. Second Water Well; and
 - iii. Wastewater Treatment Plant Improvements Project, Phase 1;
 - (b) Status of construction contracts, including the approval/and or concurrence of any pay estimates and change orders and/or acceptance of facilities for operation and maintenance purposes, authorization to accept of TEC Form 1295, approval of any related storm water permits and approving of related storm water plans, including:

- i. Installation of generators at the District's Lift Station Nos. 1 and 2 (CSE W-Industries, Inc.); and
 - ii. Installation of a generator at the District's Joint Wastewater Treatment Plant (CSE W-Industries, Inc.);
 - (c) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - (d) Approval of any consents to encroachment relative to District facilities;
 - (e) Discussion regarding the status of repairs to sidewalks and trails located within the District by Harris County Precinct 4 and Harris County Municipal Utility District No. 346;
 - (f) Status of service line inventory required under new lead and copper regulations (due October 2024); and
 - (g) 10-year Capital Improvement Plan;
9. Discussion regarding conversion to chloramine disinfectant and authorize any action in connection therewith;
10. Status of acquisition of property owned by Second Baptist Church for a second water well; authorize any action in connection therewith, including approval of engagement letter with Wilson Cribbs & Goren and proposal from Pape-Dawson Consulting Engineers, LLC, for replatting services;
11. Operator's Report, including:
- (a) Monthly Report;
 - (b) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - (c) Appeals of District charges;
 - (d) Refer accounts for collection;
 - (e) Write-off of uncollectible accounts;
 - (f) Status of water meter replacement program
 - (g) Repair and maintenance of District facilities, including fire hydrants and repair to Lift Pump No. 1 at Lift Station No. 1;
 - (h) Status of testing District's water supply for arsenic levels; and
 - (i) Submission of updated contact information and/or descriptive information regarding District facilities that qualify for critical load status to the County Office of Emergency Management, Public Utility Commission, and the Division of Emergency Management of the Governor, relative to compliance with §13.1396, Texas Water Code;
12. Consider an amendment to the Amended and Restated Professional Services Agreement between Inframark, LLC and the District;

13. Consider an Amended and Restated Emergency Water Supply Contract with Harris County Municipal Utility District No. 216;
14. Green Trails Monthly Report regarding supplemental law enforcement services;
15. Consider an amendment to the Emergency and Interim Water Supply Contract between the District and Green Trails Municipal Utility District;
16. District website and mass communication messaging matters;
17. Status of installation of a hike and bike underpass on Fry Road by Willow Fork Drainage District;
18. Authorize completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
19. Attorney's Report;
20. Discuss status of potential litigation involving the District and authorize any action in connection therewith;

23. Matters for possible placement on future agendas.
