

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 345
NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being a meeting place of the District.

The meeting will be held on Monday, August 19, 2024, at 12:00 Noon.

The Board shall consider and/or act on following matters:

1. Public comments;
2. Review and approve minutes of the July 1, 2024, and July 15, 2024, Board of Directors meetings;
3. Bookkeeper's Report, including financial and investment reports and authorizing the payment of invoices presented;
4. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
5. Receive the Financial Advisor's recommendation concerning the District's proposed 2024 tax rate, determine intended tax rate, and authorize:
 - (a) The required notice that the Board will consider adoption of a tax rate; and
 - (b) The means of providing such notice;
6. Delinquent tax collections attorney report, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
7. Engineer's Report, including:
 - (a) Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District and acceptance of Texas Ethics Commission ("TEC") Form 1295;
 - i. Water Plant Improvements Project, Phase 1;
 - ii. Second Water Well; and
 - iii. Wastewater Treatment Plant Improvements Project, Phase 1;
 - (b) Status of construction contracts, including the approval/and or concurrence of any pay estimates and change orders and/or acceptance of facilities for operation and maintenance purposes, authorization to accept of TEC Form 1295, approval of any related storm water permits and approving of related storm water plans, including:
 - i. Installation of generators at the District's Lift Station Nos. 1 and 2 (CSE W-Industries, Inc.); and


- ii. Installation of a generator at the District's Joint Wastewater Treatment Plant (CSE W-Industries, Inc.);
 - (c) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - (d) Approval of any consents to encroachment relative to District facilities;
 - (e) Discussion regarding the status of repairs to sidewalks and trails located within the District by Harris County Precinct 4 and Harris County Municipal Utility District No. 346; and
 - (f) Approval of lead service line inventory in connection with lead and copper rules for water systems due October 2024;
8. Discussion regarding conversion to chloramine disinfectant and authorize any action in connection therewith;
 9. Status of acquisition of property owned by Second Baptist Church for a second water well, including acceptance of Special Warranty Deed and Sanitary Control Easement from Second Baptist Church; status of re-plat of property for public utility purposes; authorize any action in connection therewith;
 10. Operator's Report, including:
 - (a) Monthly Report;
 - (b) Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from regulatory agencies regarding same;
 - (c) Appeals of District charges;
 - (d) Refer accounts for collection;
 - (e) Write-off of uncollectible accounts;
 - (f) Status of water meter replacement program
 - (g) Repair and maintenance of District facilities, including fire hydrants and repair to Lift Pump No. 1 at Lift Station No. 1; and
 - (h) Status of testing District's water supply for arsenic levels;
 11. Consider an amendment to the Amended and Restated Professional Services Agreement between Inframark, LLC and the District;
 12. Approval of an amended Rate Order in connection with Inframark, LLC's revised schedule of rates;
 13. Green Trails Monthly Report regarding supplemental law enforcement services;
 14. District website and mass communication messaging matters;
 15. Status of installation of a hike and bike underpass on Fry Road by Willow Fork Drainage District;

16. Attorney's Report;
17. Convene Closed Session for consultation with attorney regarding pending or threatened litigation or matters protected by attorney-client privilege pursuant to Section 551.071, Texas Government Code, as amended, and deliberation regarding the purchase, exchange, lease, or value of real property pursuant to Section 551.072, Texas Government Code, as amended;
18. Reconvene in Open Session and authorize any actions related to matters discussed in Closed Session; and
19. Matters for possible placement on future agendas.
