NOTICE OF PUBLIC MEETING**

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas 77056, said address being a meeting place of the District. Said meeting will also be conducted via videoconference pursuant to Texas Government Code, Section 551.127, as amended. All members of public may participate in the meeting in person or via videoconference.

The meeting will be held on Monday, October 20, 2025, at 12:00 Noon.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Review and approve minutes of the September 15, 2025, Board of Directors meeting;
3. Conduct a public hearing regarding the adoption of the District's 2025 tax rate;
4. Levy of the District's 2025 maintenance tax rate, and the adoption of an Order in connection therewith;
5. Approval and execution of an Amendment to the Amended and Restated District Information Form;
6. Bookkeeper's Report, including financial and investment reports and authorizing the payment of invoices presented;
7. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
8. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented and approve moving of accounts to uncollectible roll;
9. Authorize preparation and filing of initial Local Government Bond, Tax, and Project report pursuant to Chapter 403, Texas Government Code, as amended by H.B. 103;
10. Delinquent tax collections attorney report, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
